#### **EXTRACT FROM THE**

## Regulation on the right of choice of elective courses by students in

#### IVANO-FRANKIVSK NATIONAL

#### MEDICAL UNIVERSITY

### 1. General provisions

- 1.1. Applicants of a certain level of higher education have the right to choose disciplines offered for other levels of higher education, in agreement with the head of the relevant faculty or department.
- 1.2. Educational disciplines of the student's choice are disciplines that are introduced to more fully meet the educational needs of the individual for the needs of society, more effective use of the University.
- 1.3. The catalog of elective disciplines is a list of disciplines of free choice by applicants for a certain level of higher education in fundamental and professionally-oriented areas of training.
- 1.4. The choice of disciplines of the variable part of the educational program the applicant carries out at formation of the individual curriculum.
- 1.5. Educational programs provide free choice for students of academic disciplines in a particular area.

# 2. Terms, definitions and accepted abbreviations

# 3. Organizational and methodological support of the right of choice of free choice disciplines by students

- 3.2. Disciplines of free choice make not less than 25% of the total number of ECTS credits of all disciplines of OP.
- 3.4. The study of free choice disciplines continues during the semesters specified in the working curricula.
- 3.5. The form of control of the discipline of choice exam, final modular control, credit.

## 4. Educational and methodological support of elective disciplines

- 4.1. The list of elective subjects for a particular specialty is consistent with educational programs and curricula.
- 4.2. The number of elective courses and ECTS credits allocated for their study, forms of control are determined by the OP and recorded in the individual curriculum of the student.

# **5.** The order of formation of the selective component of the individual curriculum of the applicant

- 5.1. The formation of groups of applicants for the study of elective courses for the next academic year is carried out by deans during the spring semester of the current academic year until May 31 (for applicants for the first year of study during the autumn semester of the current academic year until December 20) by reading the Catalogs on the University website.
- 5.2. Applicants determine their choice to study specific disciplines, make a direct record of disciplines in the form of an application.
- 5.3. Based on the applications of students, deans of faculties form orders to create groups to study elective subjects for the next academic year, providing conditions for a minimum number of applicants (at least 10 people), based on the principle of optimizing groups that can be enrolled in a particular discipline. priority.
- 5.5. If the applicant for a good reason could not apply in time for the study of elective courses, he has the right to apply, submitting the relevant documents to the dean's office with an application for enrollment in the study of his chosen disciplines before the next semester (no later than two working weeks).
- 5.6. Selected disciplines are included in the curricula of OP and determine the study load of the departments.
