The excerpt from the regulations on educational and practical centres of Ivano-Frankivsk National Medical University

1. General provisions

- 1.1. Training and practical centres (hereinafter Centres, TPC) are educational units of Ivano-Frankivsk National Medical University (hereinafter the University, IFNMU) established on the basis of the departments of the University and practical health care and pharmacy.
- 1.2. The list of TPC of IFNMU:
- "Medicine":
- "Dentistry";
- "Pharmacy".
- 1.3. The purpose of the Centres is the training, retraining and advanced training of students in educational programs (EP), improving the practical training of students, using modern technologies to practice and master practical skills.
- 1.4. The main purpose of the Centres is to train specialists at the undergraduate level at a high professional level.
- 1.5. In their activities, the Centres involve the application of a simulation-training approach to the acquisition and mastery of practical skills and manipulations, as well as multidisciplinary integration.
- 1.6. The centres are subordinated to the Rector of the University.
- 1.9. Within the activities of the Centres it is planned to organize cooperation with other higher medical (pharmaceutical) educational institutions of the Ministry of Health of Ukraine, Research Institute of Ukraine with the creation of joint distance learning programs, telecommunication programs, algorithms for practical skills, development of new forms and methods of practical training aiming to improve the efficiency of assimilation of mastering of practical skills of working with medical equipment.
- 1.11. The activities of the Centres include the introduction of elements of distance learning in the educational process at the undergraduate level.

2. The main directions of work of the Centres:

- educational
- organizational
- medical and diagnostic
- rehabilitational
- pharmacy and technological integration.

3. The main functions and tasks of the Centres:

- 3.1. Educational and methodical work
- 3.1.1 Preparation and approval in the prescribed manner of working curricula in the system of undergraduate education of specialists.
- 3.1.2 Development and implementation of algorithms for practicing of practical skills and manipulations.
- 3.1.3 Participation in the improvement of educational and professional programs with an emphasis on practical training.
- 3.1.4 Implementation of undergraduate training of students in accordance with the curricula and programs.

- 3.1.6 Organization and implementation of elements of distance learning at the undergraduate level.
- 3.1.7 Organization and conducting of simulation trainings with practical skills, skills of work with modern medical and rehabilitation equipment.
- 3.1.8 Creation of presentations, thematic educational films, electronic manuals for classes and trainings.
- 3.2 Medical-diagnostic and rehabilitation work
- 3.2.1 Carrying out diagnostic, medical and rehabilitation work in the educational process during practical classes, involvement of the contingent of learning students in it.
- 3.2.2 Preparation and approval in the prescribed manner of protocols for monitoring, diagnosis, treatment and rehabilitation of patients.
- 3.2.4 Participation in conducting clinical, initial and practical conferences.

3.3 Pharmacy and technological work

- 3.3.2 Conducting classes on pharmacy technology of drugs.
- 3.3.2 Assessment of the quality of the prepared drug in accordance with regulatory and technical documentation.
- 3.3.5 Work on the equipment and apparatus for obtaining finished and intermediate products.
- 3.4 Organizational work
- 3.4.3 Organization of the sanitary-educational work and preparation of materials for the University site on the issues of practical training of specialists at the undergraduate and postgraduate stage of study.
- 3.4.4 Development of criteria for assessing the quality and effectiveness of learning and mastering practical skills.
